**THERMOPOLIS COWBOY RENDEZVOUS PRCA RODEO QUEEN/SR
PRINCESS CONTRACT 2017**

I, _____, having voluntarily participated in the Thermopolis Cowboy Rendezvous PRCA Queen/Sr. Princess Contest with full knowledge and understanding of the Guidelines, Rules and Expectations as well as the terms and conditions of this Contract. I further understand that I am being designated to serve as the Thermopolis Cowboy Rendezvous PRCA Rodeo Queen/Senior Princess and serving as such am required to enter into this Contract as a condition of being to designated, make the following statements and representations to, and agreements with the Thermopolis Cowboy Rendezvous PRCA Rodeo Committee and the Thermopolis Cowboy Rendezvous PRCA Rodeo Queen/Sr. Princess Committee, and being first duly sworn upon oath, do depose and say:

1. I am a natural born female citizen of the United States of America and reside in _____, County of _____, State of Wyoming.
2. I meet the resident requirements put forth by the Thermopolis Cowboy Rendezvous PRCA Rodeo Queen Committee.
3. My age meets the requirements set forth in the Royalty Guidelines, Rules and Expectations.
4. I have never been married, had the marriage annulled or had a child out of wedlock. I have never been, nor am now pregnant. I am not cohabiting or sharing living quarters with a person of the opposite sex not related to me.
5. I am of good moral and ethical character and have never been convicted of any crime.
6. I have not heretofore authorized any person, firm or corporation to use my name, photograph, picture, present or future title in connection with an endorsement or advertisement of any commercial product or service. I am not under contract or other obligation to any person, firm or corporation with respect to my present title. I have not made any commitment nor do I have any legal obligation which would prevent my participation in an appearance at the Thermopolis Cowboy Rendezvous PRCA Rodeo, Miss Rodeo Wyoming Contest or the Miss Rodeo America Pageant, or which would prevent or hinder my compliance with the terms, conditions and obligations hereafter specified.

NOW, THEREFORE, IN AND FOR THE CONSIDERATION of my being designated "Thermopolis Cowboy Rendezvous PRCA Rodeo Queen/ Sr. Princess" and for other good and valuable consideration, I hereby agree as follows:

1. During my term as "Thermopolis Cowboy Rendezvous PRCA Rodeo Queen/Sr. Princess," the length of which term shall be determined by the Thermopolis Cowboy Rendezvous PRCA Rodeo Queen Committee, I shall not become a contestant or participant in any other beauty or talent pageant or contest to make or agree to make any public appearance of any kind without the express permission of the Thermopolis Cowboy

Rendezvous PRCA Rodeo Queen Committee, which permission shall not be granted in any case where my participation in such event would be in violation of the rules and regulations of the Thermopolis Cowboy Rendezvous PRCA Rodeo Queen/Sr. Princess Contest, the Thermopolis Cowboy Rendezvous PRCA Rodeo Committee, the Thermopolis Cowboy Rendezvous PRCA Rodeo Queen Committee, the Miss Rodeo Wyoming Contest or the Miss Rodeo America Pageant.

2. I warrant that all of the above statements and representations made by me are true. In addition, I agree that during my term as “Thermopolis Cowboy Rendezvous PRCA Rodeo Queen/Sr. Princess” I shall conduct myself in a manner in which shall uphold and maintain the dignity and the honor of that title and position. I will not engage in any illegal use of drugs or alcohol during the extent of my reign. I will not be present in a public bar while holding the title of Thermopolis Cowboy Rendezvous PRCA Rodeo Queen/Sr. Princess unless it is the location of a (Committee) required event. I will refrain from any personal relationships that could appear to encumber my ability to perform the duties of my title while attending royalty events. I further agree that during my term as “Thermopolis Cowboy Rendezvous PRCA Rodeo Queen/Sr. Princess” I shall not become pregnant or married.

3. I hereby designate and appoint the Thermopolis Cowboy Rendezvous PRCA Rodeo Queen Committee , as my sole and exclusive representative and agent for making press releases, statements to news media, contacts, engagements and appearances during my term as “Thermopolis Cowboy Rendezvous PRCA Rodeo Queen/Sr. Princess.” I agree to make myself available for such appearances, interviews, filmings, tapings, photographic and recording sessions, and such other events as are determined by the Thermopolis Cowboy Rendezvous PRCA Rodeo Queen Committee, provided that such shall not unreasonably interfere with my educational and/or employment pursuits. In addition, I authorize the Thermopolis Cowboy Rendezvous PRCA Rodeo Queen Committee to collect for and on my behalf all compensation if due me by reason of the foregoing and upon collection thereof to pay the same to me; provided, however, that nothing herein contained is intended or shall be construed as any guaranty by the committee, of any contracts, engagements or appearances for the same but is intended solely to attempt to protect the honor and dignity of the title and office of “Thermopolis Cowboy Rendezvous PRCA Rodeo Queen/Sr. Princess” and my personal participation and interest therein.

4. I understand that if I am awarded the title of “Thermopolis Cowboy Rendezvous PRCA Rodeo Queen” that I will be obligated to enter and compete in the Miss Rodeo Wyoming competition for the title of Miss Rodeo Wyoming. I further agree that I will compete at all levels of said competition to the best of my abilities.

5. The Thermopolis Cowboy Rendezvous PRCA Rodeo Queen Committee may (but shall not be required to) designate my chaperon and traveling companion while I am engaged in activities related to my participation in events as “Thermopolis Cowboy Rendezvous PRCA Rodeo Queen/Sr. Princess.”

6. I understand that if I do not comply with the terms and conditions of the Thermopolis Cowboy Rendezvous PRCA Rodeo Royalty Guidelines, Rules and Expectations as well as the terms of this Contract, that the Thermopolis Cowboy Rendezvous PRCA Rodeo Queen Committee has the absolute right to request that I resign the title and office of “Thermopolis Cowboy Rendezvous PRCA Rodeo Queen/Sr. Princess” in which event I shall so immediately resign as and forfeit the right to said title and office. In addition, upon my resignation I shall forfeit and return to the Thermopolis Cowboy Rendezvous PRCA Rodeo Queen Committee all awards, prizes and education funds to which I would otherwise be entitled. In the event of my resignation,

whether voluntary or upon the request of the Thermopolis Cowboy Rendezvous PRCA Rodeo Queen Committee, I recognize the right of the Thermopolis Cowboy Rendezvous PRCA Rodeo Queen Committee to select my successor and such person so selected shall be entitled to receive such prizes, awards and education fund as may be determined by the Thermopolis Cowboy Rendezvous PRCA Rodeo Queen Committee .

7. I understand that scholarships may be administered and awarded by the Thermopolis Cowboy Rendezvous PRCA Rodeo Queen Committee. Scholarship is subject to available funds and shall not exceed \$1,000.00. I agree to accept and abide by the terms thereof if such an award is made to me. I understand and agree that I must maintain at least a 2.0 grade point average as a condition of receiving any scholarship. I further agree to provide to the Thermopolis Cowboy Rendezvous PRCA Rodeo Queen Committee a certified copy of my grade transcript prior to any scholarship monies being requested. Scholarship money will be paid directly to the educational institution in which I am enrolled.

8. I agree that as “Thermopolis Cowboy Rendezvous PRCA Rodeo Queen/Sr. Princess” I will dress appropriately, in western apparel, complete with crown and banner, at all public appearances, and be appropriately groomed at all times.

9. I agree that this contract shall solely and exclusively determine my rights and obligations relating to my duties and responsibilities during my term as “.Thermopolis Cowboy Rendezvous PRCA Rodeo Queen/Sr. Princess” In the event of any occurrence or situation arising or any personal acts that I perform during my term as “Thermopolis Cowboy Rendezvous PRCA Rodeo Queen/Sr. Princess” which is or are not specifically covered by this Contract which, in the opinion of the members of the Thermopolis Cowboy Rendezvous PRCA Rodeo Queen Committee, jeopardize or threaten the reputation of public standing of the title and office of “Thermopolis Cowboy Rendezvous PRCA Rodeo/Sr. Princess,” the members of the Thermopolis Cowboy Rendezvous PRCA Rodeo Queen Committee may take whatever action they, in their sole discretion, deem appropriate, including the remedies hereinabove specified. While Board actions are Final, the Board assures royalty it will take action only based on substantiated violations(s) in regard to this contract and offer royalty opportunity for written and/or oral presentation prior to rendering a decision.

10. I understand and agree that I shall be solely responsible for my personal property and physical well-being; and that I shall neither ask for, expect, nor receive compensation, or reimbursement from the Thermopolis Cowboy Rendezvous PRCA Rodeo Queen Committee, its members, officers, employees or agents.

11. I agree that if chosen “Thermopolis Cowboy Rendezvous PRCA Rodeo Queen/Sr. Princess” upon completion of my reign that I will return all items that are on loan to me (ex: sash, chaps, magnetic signs, etc.) to be passed on to future title holders or pay the equivalent amount of each item to the Thermopolis Cowboy Rendezvous PRCA Rodeo Queen Committee.

12. I hereby release, remise, acquit, and discharge forever and agree to indemnify, defend, and hold harmless the Thermopolis Cowboy Rendezvous PRCA Rodeo, the Thermopolis Cowboy Rendezvous PRCA Rodeo Committee, it’s members, officers, employees or agents for any injury or loss sustained by me or to my property as a result of participating in Thermopolis Cowboy Rendezvous PRCA Rodeo Royalty Program, it’s events or any activity under this Contract. I further release and agree to indemnify and hold harmless the Thermopolis Cowboy Rendezvous PRCA Rodeo Queen Committee, its members, officers, agents, and
